<b>Appliances</b>	Refrigerator, freezer, stove, vent hood, washer, dryer, microwave. 10 years or newer. Check <a href="http://www.appliance411.com/service/date-code.php">www.appliance411.com/service/date-code.php</a> to determine age of your appliance.	Commercial appliances, SubZero refrigerators, used dishwashers, wall or double ovens, garbage disposals, cooktops, dehumidifiers, household vacuum cleaners.
<b>Architectural</b>	Mantels (factory painted or stained), columns (10 ft. maximum), framed stained glass, wrought iron railings and spindles.	Gas fireplaces/fireplace inserts. Hand painted items.
<b>Building Materials</b>	Drywall (4'x4' or 4'x8'), Lumber (6' or longer), Plywood or OSB (2'x4' or larger), baseboard, trim (6' or longer), unopened bags of concrete, metal or plastic shelving, NEW Paint (nothing over 3 years old, no partially used cans)	USED Paint (no partially used cans) or Stain
<b>Doors</b>	Residential interior doors (wood, metal, bi-fold, or glass), Exterior doors, new storm doors, new sliding patio doors with frame (72"x80" or smaller).	Shower doors, garage door or garage openers.
<b>Electrical</b>	Residential and current code only: electrical parts, wire, hardware, outlets, plate covers, and light switches.	Electronic items like TVs, computers, CD/DVD players, printers, copiers, fax machines, office equipment.
<b>Flooring</b>	New carpet (rolled), new vinyl, clean/unstained rugs, unopened boxes of luxury plank vinyl, hardwood flooring, or tile, unopened grout, mortar, and adhesive.	Loose or partial boxes of tile.
<b>Furniture</b>	Leather/upholstered chairs, couches, loveseats, dining tables and chairs, futon frames, home office desks (5' or less), bookshelves, side tables, coffee tables, dressers, nightstands, and bed frames.	Mattresses, box springs, entertainment centers, built-in wall storage, sofa beds, hide-a-beds, sleeper sofas, hutches, large desks.
<b>Hardware</b>	Residential knobs, hinges, locks, original boxes of fasteners.	
<b>Home Exterior</b>	New shingles, new insulations, new gutters.	Loose insulation, used shingles, garage doors, garage door openers.
<b>Home Interior</b>	New shutters, framed mirrors, large framed art, lamps, small household/home décor items, clean/unstained rugs.	Window coverings including all blinds, curtains, and valances, unframed mirror or glass.
<b>HVAC</b>	New air conditioners, furnaces, central air systems, venting material, water heaters.	
<b>Kitchen Cabinets</b>	Cabinets with doors, drawers and hinges attached. Box cabinets only. Sinks, laminate countertop, cabinet knobs and other hardware.	
<b>Landscaping, Lawn and Garden</b>	Clean/not broken bricks and blocks, edging, fencing, lawn or patio furniture, yard tools, gently used grills.	Loose landscape rocks, gas/oil, gas cans, playground equipment, dirty materials.
<b>Lighting</b>	Chandeliers, flush mount lights, pendant lights, sconces, new light bulbs, table lamps, floor lamps, ceiling fans (must have all hardware).	Track lighting, fluorescent shop lights, used light bulbs.
<b>Office Furniture</b>	Desks (5' or smaller), desk chairs, lobby furniture, breakroom furniture, two drawer file cabinets.	Built in cabinets, L-Shaped desks, cubicles, conference room tables, printers, copiers, or fax machines.
<b>Plumbing &amp; Bathroom</b>	New tubs, medicine cabinets, shower surrounds, new PVC and metal piping, plumbing supplies, sinks, vanities, toilets	Cast iron sinks, shower doors, unframed mirrors, water softeners.
<b>Tools</b>	Working power tools, cordless power tools, hand tools, aluminum ladders, fiberglass ladders, shop vacs.	Recalled items, homemade tools.
<b>Windows</b>	Single pane, fixed pane, storm windows, new complete units with all sashes and frames, metal screens.	

Other items NOT accepted: Hazardous materials, toxic chemicals, pesticides, fertilizers, exercise equipment, bicycles, mattresses or box springs, automobile parts, electronics, musical instruments, medical equipment, small household appliances, kitchen supplies, children's items/toys, clothing, textiles.
